Sir,

I have the honour to report you that today i.e. 07/11/2023 at about 7:30 am the CRP Team deployed for Naka duty has detained one Bolero b/Regd. No. MN03P/7773 white in colour at Kangchup Chingkhong. The Bolero, white in colour was carrying five individuals i.e. 2 woman and 3 men. It was on its way from Churachandpur to Leimakhong and like took a wrong route. In the meantime, a large and enraged mob of Meitei confronted and forcibly took away took four individuals suspected to be of Kuki Community. But one of them was escaped from the mob. it is also learnt that one of them was later found and rescued by the security with injury on his person. Identities of the individuals' couldn't be known. A strong combined security team conducted men hunt operation around the neighboring villages and suspected routes to rescue them but couldn't found them.

You are therefore requested to take up necessary legal action against the unknown Meitei Miscreants.
