Today i.e. 07/11/2023 at 12:30 pm received information that on the date at about 12:10 pm amidst the confrontation between the mob and security forces, armed miscreants started firing towards the security forces and the mob from K. Songlung hill range. It is also learnt that at the same time armed miscreants from Koutruk and Tairenpokpi hill range Security forces also retaliated firing towards the armed miscreants. In the incident 02 (two) police personnel namely (1) Constable No. 1909195 Naorem Kishan Singh (30) S/o N. Tiken Singh of Mayang Imphal Konchak and (2) VDF No. V112589 M. Basanta Singh S/o M. Kesho Singh of Mayanglangjing Sorok Mapal and 7(seven) Civilians sustained bullet injuries on their persons. They were evacuated to Hospital for further treatment. 4(four) police vehicles including Bullet proof vehicles also caused damaged as hit by the bullets of armed miscreants.,

Hence a Suo Motto FIR No. 632(11)2023 LSG-PS U/S 307/326/427/34 IPC and 25(1-C) Arms Act has been registered against the unknown armed miscreants suspected to be Kuki armed militants for investigation
