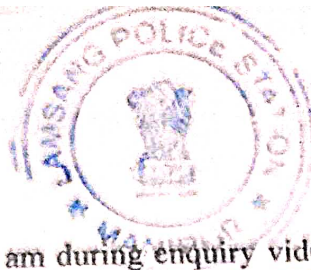

Today i.e 02/12/2023 at 10:00 am during enquiry vide G. D entry No. 14/LSG-PS/2023 dated 30/11/2023 in c/w the firing incident at Koutruk on 30/11/2023 from 3:30 pm that the several rounds of firing just above the hill range of Koutruk and towards the Koutruk village started at @ 3:30 pm of the same day i.e 30/11/2023 suspected to be between the valley base Meitei groups and hill base Kuki armed miscreants/militants using sophisticated weapons, bombs/explosive and attempt to life and property of the public, in which the combine team of 3rd IRB, 7th IRB, 7th MR and civil Police personnel at the Koutruk Ching Leikai and NSUI campus Koutruk post have ensued counter firing and retaliation by firing several rounds to save life and property and it was lasted till about 4:10 pm of the same day i.e 30/11/2023.

Hence a suo-motto case under FIR No. 635(12)2023 LSG-PS u/s 307/506/34 IPC, 25(1-A)A. Act & 3 Expls. Subs. Act. has been registered for investigation.
