



I am writing this letter to bring to your attention an unfortunate incident involving a hit and run accident that occurred on 13<sup>th</sup> Dec' 2023 at approximately 1940 hrs (07:40 pm). The victim of the accident is No. 902431173 ASI Mukesh Kumar of E' coy 176 Bn BSF i.e. myself was on duty at that time.

Details of the Incident:

1. Date and Time: The accident took place on 13<sup>th</sup> Dec '2023, at around 1940 hrs.
2. Location: The incident occurred on NH opposite to gate no.1 of 2nd Manipur Rifles between AOC and Khongnang ani karak.
3. Victim Details: The BSF personnel who was hit by an unknown white bolero vehicle while on duty is identified as:

I was struck by a white bolero of unknown number. The vehicle was driving at a high speed, and the driver fled the scene without stopping to assist or provide any necessary help.

1. Initiate a thorough investigation into the hit and run accident kindly identify & apprehend the responsible person involved.
2. Kindly employ all available resources to apprehend the driver responsible for the accident and bring them to justice.
3. Regular Case Updates: Request regular case updates regarding the investigation, as it is crucial for the me and our organization to stay informed about the progress.

3. Photographs of my injuries.
4. Medical slip of RIIMS.

That might assist with the investigation.
