

Today i.e. 14/12/2023 at 08.40 PM, received an information that on the same day at about 08.35 pm, one unknown male pedestrian was knocked down by one Hyundai Nios i10 Grand, Aqua Green in colour, bearing Regn No. MN01AG9188 at Uripok Achom Leikai which was plying from Imphal towards Naoremtheong along Uripok Kangchup Road, due to rash and negligent driving on the part of the driver of the Hyundai Nios i10 Grand. As a result of which the said pedestrian received injuries on his person and he was evacuated to Hospital for medical treatment. However, the concerned doctor of the Raj Medicity Hospital declared brought death. Further, the said i10 Nios car was also badly damaged.

Hence, a suo-mottu case under FIR No. 889(12)2023 IPS u/s 279/338/427/304-A IPC has been registered for investigation.
