REPORT

With reference to SP-CCP Orders, No. B-16/14/SP-CCP/2012/5764 dated 26/11/2023 a combine team of Behiang Police, SDO/SDM-SGT, NAB, Forest Dept. and 46 AR with Churachandpur District Police led by DSP-CCP, under the supervision of SP-CCP were detail to carried out destruction of illicit opium poppy cultivation at Suangkuang village area under Behiang Police Station on 27/11/2023. There, SDO/SDM-SGT furnish attachment and destruction order of the illicit poppy cultivation in the said area u/s 48 of ND&PS Act 1985, as amended.

The combine team meet at Singngat PS and the team proceeded at 07:00 am and reach at Suangkuang village hill rang at around 11:00 am of the day. The area of the land was found to be approximately 40 Acres. Some of the cultivated area was already destrurcted by the villagers and most of the area were not cultivated for the current year. The remaining approximate 12 acres of cultivated poppy plant was destroyed by the combined team. The cultivation was on the top and slops of the ridge and cultivated far away from the view of the people around the area. No one came forward to claim the ownership of the cultivation.

Then, we examine the plant systematically and confirmed that the same was opium poppy plants. One of the poppy pot/flowering top was cut with a sharp blade which producess white milky fluid. On closure examination it was found that in a 1/1 meter area there were about 08 plants approximately. Hence five poppy pot have been seized in presence of witness. Then the illicit poppy were cut down/uprooted and burned as per provision of Law the destructed area is expected to yield about 20kgs of opium. Detail of the photography befor, during and after destruction were taken for adducing evidence if required in the court of the law. Therefore, a suo-moto case is registered for further investigation.
