Respected Sir,

I, the undersigned beg to report for your kind and necessary action.

1. That, on 3rd May 2023 at around 7:30 pm while I was at my rented house attached with my Physiotherapy Clinic located at Churachandpur Tuibong Bazar, some unknown miscreants suspected to be Kuki militants stormed our Meitei locality area with arms and other incriminating weapons. They have started vandalizing and looted all the valuable properties inside my rented house including Physiotherapy Clinic instruments from my clinic.

2. That, the value of the looted/damaged properties is around Rs. 15,54,500/- (Rupees fifteen lakhs Fifty four thousand five hundred) approximately.

3. That, the unknown armed miscreants warned and threatened me to leave the village permanently and that I will face dire consequences if we return to our village again.

4. That, I could not report well in time due to the present law & order situation as well as I was displace and stranded. I am taking shelter at Kumbi Terakhunou Primary School Relief Camp from 9th May 2023 till date.

It is, therefore, requested to take up necessary action in accordance with law against the unknown miscreants suspected to be Kuki tribes, Kuki militants.
