Sir,

I, the undersigned, have the honour to state that on 10th March, 2023 I went to Boboy Workshop at Thingkangphai Kawnpui, Churachandpur for repairing my Bolero white in colour bearing registration no. MN01X 7232, Engine No.GPC4F13145 and Chassis No. MA1PL2GPKC2F78606. Later, he told me to come on 6th May to take my vehicle. I gave Rs.60,000/- advance for repairing the said vehicle. However, I could not go to the said workshop on that Scheduled day due to the communal riot which started from 03/05/2023 between Meitei and kuki community. Later, on 11/05/2023 at 6:30 pm received a reliable information that, the said vehicles was looted by unknown Kuki armed miscreants. The approximate value of the lost/looted vehicles are @ Rs.4,15,000/-(Four Lakhs Fifteen Thousand). Delay of filing of this report is due to the current unrest law & order situation.

So, I therefore request you to kindly take up legal necessary actions against the above mentioned unknown accused.
