Sir,

I, the undersigned have the honour to state that a large number of unidentified people belonging to the Kuki community with deadly weapons and sophisticated arms including Kuki militant groups stormed the Meitei inhabited areas of Hiyangzou, New Zou Veng, Churchandpur under Churchandpur P.S., Churchandpur District on 3<sup>rd</sup> day of May, 2023 at 4:30 pm. The said unidentified groups looted poultry farming accompanied with a chicken centre in addition to a chicken feed materials at the rented house of Kimhoinung, of Hiyangzou, New Zou Veng, Churchandpur. In such terrible acts of the said unidentified groups, I along with my family members ran away from Hiyangzou, New Zou Veng, Churchandpur, Churchandpur District to save our life and we were rescued by a team of Assam Rifle and shifted us at Mini Secretariat, Tuibong, and shifted at Imphal Khuman Lampak for one day. Then, we took shelter at Khekman and now staying at the relief camp of Samurou Govt. High School, Samurou since 13/9/2023. In that unfortunate incident I have lost my property amounting to a total amount of Rs. 30,00,000/-(thirty Lakhs) only.

It is therefore, requested kindly initiate and take necessary legal actions against the accused persons involved in the said inhuman and barbarous act, as per law of the land as early as possible. I couldn't able to submit my complain report in time due to prevailing inconvenient situation.



Complainant statement of Thongam Bimolchan Singh (51) s/o (L) Th. Chandra Singh of Langathel Mayai Leikai, Thoubal District, A/P Churchandpur Hiyangzou, PO & PS- Churchandpur, recorded in c/w FIR NO.81(9)2023 WGI-PS U/S 147/148/188/382/427/400/34 IPC.

My particulars are given above. I was born and brought up at Langathel Mayai Leikai. Now I was staying at a rent house located at Churchandpur Hiyangzou since 2019. The owner of the rent house is one Mrs. Kimholnu (48) of Churchandpur Hiyangzou. Now I have no homestead land at my native village i.e. Langathel village.

Qualification : I have completed class X.

Marital Status : I am a married person. The details of my wife is Puyam (n) Premila Devi d/o P. Birenjit Singh of Langathel in the year 2007.

Profession : I am a businessman, I am running a shop at Churchandpur Hiyangzou.

Issues : I have three issues.

a) Mr. Abu Thongam (15)

b) Miss. Lanchenbi Thongam(10)

c) Mr. Thoihenba Thongam (6)


Profession of wife : My wife is a house wife.

How the incident was happened : On 3<sup>rd</sup> May, 2023, at about 5.30 pm, while I and my family was staying at my rent house, the houses of the Meiteis were started burning down by a large group of Kuki community including Kuki militants. I along with my family went out from the place to save our lives. We hid ourselves in a pit which is located at the neighbouring house's campus. On the next day i.e. on 4<sup>th</sup> May, 2023, at about 6.00 am, we were rescued by a team of Assam Rifle and shifted us at Mini Secretariat, Tuibong. It is learnt that my properties which are kept inside my rent house were all looted and vandalised by the said culprits. Due to the incident, I have lost my properties of about Rs. 30,00,000/- (thirty lakhs).

We were shifted at Imphal Khuman Lampak by Assam Rifles on 10<sup>th</sup> May, 2023. We stayed at Khuman Lampak for one day. Then, we took shelter at Khekman who is our relative. On 13<sup>th</sup> Sept, 2023, I along with my family shifted to the Relief Camp located at Samurou.
