Sir,

I, the undersigned have the honour to state that a large number of unidentified people belonging to the Kuki community with deadly weapons and sophisticated arms including Kuki militant groups stormed the Meitei inhabited areas of Churchandpur Old Bazar Mamang Leikai on 3rd day of May, 2023 at about 8.00 Pm. The said unidentified groups looted the household materials and burnt down my house. In such terrible acts of the said unidentified groups, I ran away from Churchandpur Old Bazar to save my life and took shelter at different places. And started staying at the relief camp of Kamakhya Pemton College, Hiyangthang since 11/6/2023. In that unfortunate incident I have lost my property amounting to a total amount of Rs. 15 lakhs (Fifteen lakhs) approximately.

It is therefore, requested kindly initiate and take necessary legal actions against the accused persons involved in the said inhuman and barbarous act as per law of the land as early as possible. I couldn't able to submit my complain report in time due to prevalling inconvenient situation.


My particulars are stated above. I was born and brought up at the above mentioned place. Presently I resided at the Kamakhya Pemton College, Hiyangthang, I/W District, Manipur since 11th June, 2023. I am the last son among four siblings of my parents. I have one elder brother and two elder sisters. My educational qualification is Class VIII passed. My parents were expired due to illness. I got married with one namely Premila from Churachandpur and divorced. I am a mason (Jugali).

On the eventful day of occurrence of the crime i.e. 3rd May, 2023 at about 08:00 pm while I was sleeping at my residence located at Churachandpur Old Bazaar Mamang Leikai, suddenly a large number of unidentified people belonging to the Kuki community with deadly weapons and sophisticated arms including Kuki militant groups stormed the Meitei inhabited areas of Churachandpur Old Bazaar Mamang Leikai, under Churachandpur P.S. The said unidentified groups looted the household material and burnt down my house. In such terrible acts, I got frightened that I might have lost my life. So I ran away from my house to save my life and took shelter at different places. Presently I had been staying at the relief camp of Kamakhya Pemton College, Hiyangthang since 11/6/2023. In that unfortunate incident, I have lost my property amounting to a total amount of Rs. 15,00,000/- (Rupees Fifteen Lakhs) only. On 17th September, 2023 I lodged a written report to O.C. - Wangoi PS for taking necessary legal actions against the accused persons involved in the said inhuman and barbarous act as per law. I couldn't able to submit my report in time due to the prevailing inconvenient situation.


