I, the undersigned have the honour to state that a large number of unidentified people belonging to the Kuki community with deadly weapons and sophisticated arms including Kuki militant groups stormed the Meitei inhabited areas of Khumujamba Meitei Leikai under Churchandpur PS on 4 day of May, 2023 at 11:00 pm. The said unidentified groups looted some household materials from my rented house which was owned by Konthoujam Rajesh (24) S/o. (L). K. Rame Singh of Khumujamba Meitei Leikai and they also break down some portion of my rented house. In such terrible acts of the said unidentified groups, I ran away from my house to save my life and took shelter at different places. Now staying at the relief camp of Kamakhya Pemton College, Hiyangthang since 9/8/2023. In that unfortunate incident I have lost my property amounting to a total amount of Rs. 20,00,000/-(twenty Lakhs) approximately.

It is therefore, requested kindly initiate and take necessary legal actions against the accused persons involved in the said inhuman and barbarous act, as per law of the land as early as possible. I couldn't able to submit my complain report in time due to prevailing inconvenient situation. Reveated as of of AX No.
