Sir,

I am to bring to your kind notice that I, Shri Paukhanlal (39 years) S/o Khaitinlun Vaiphei, belonging to Vaiphei Tribe and a permanent resident of Phuaisanphai, Kangvai Sub- Division, Churachandpur District, Manipur.

That, I am the Secretary of the School Managing Committee of Phuaisanphai JBS, at Phuaisanphai, Churachandpur.

That, on the 24th May, 2023 at about 3:45 am, a group of Meitei radicals suspected to be of Arambai Tenggol, Meitei Leepun came to Phuaisanphai village and burnt down the Phuaisanphai JBS building including all the important documents and infrastructures, school kitchen and its materials.

These criminals were destroying and burning every valuable properties **Rupees 27,00,000/- (Twenty - seven lakh only) (Approx.)**

I, therefore, request you to kindly take strong actions against the perpetrators by registering an FIR under relevant sections of the statutes of our country.
