

Subject – Report on vandalism and burning of properties on (Movable/Immovable)

Sir,

I am to bring to your kind notice that I, Shri Lamneimang Vaiphei (68 yrs) S/o (L) Soitin Vaiphei, belonging to Vaiphei Tribe and a permanent resident of T. Khawvaiphei, Kangvai Sub- Division, Churachandpur District, Manipur.

That, I am the Chairman of Vaiphei People's Council (VPC) Kangvai Block, Churachandpur.

That, the Vaiphei People's Council, Kangvai Block office is located at Kangvai Bazar, Churachandpur. It is a wooden one storey building and a separate caretaker quarter within the campus.

That, on the 3rd May, 2023 at about 7:30 pm, a group of Meitei radicals suspected to be of Arambai Tenggol, Meitei Leepun came to Kangvai village and burnt down the VPC Kangvai Block office including its caretaker quarter, furnitures, important documents and all the assets.

These criminals were destroying and burning every valuable properties **Rupees 40,20,000/- (Forty- lakh twenty thousand only) (Approx.)**

I, therefore, request you to kindly take strong actions against the perpetrators by registering an FIR under relevant sections of the statutes of our country.
