Sir.

I, the undersigned have the honour to state that large number of innumerable unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including kuki militants groups stormed to all Meitei inhabited areas of Churachandpur Town on 3rd day of May 2023 at around 07:30 pm. The said unidentified groups vandalised/burnt down my house located at Khuga Meitei Christain Leikai Zenhang Lamka, Churachandpur and looted all valuable items. In that unfortunate incident, I have lost a total amount of Rs. 20,00,000/-(twenty lakh). After the said unfortunate incident/mob violent, my family are fleeing from our village and my family is taking shelter at Langol Game Village Zone- 1, B-259. I could not report in time while I was treatment for my health problem.

It is, therefore, prayed that the respected sir may kindly initiate and take necessary legal action(s) against the accused persons and the persons involved in the said inhuman acts and heinous crime committed by the accused persons and persons involved as per law of the land as early as possible

I shall be grateful for your kind co-operation and necessary actions (s).
