Subject: Request for lodging an FIR case regarding looting and ransacking/burnt down of my house located at Churachandpur on 6<sup>th</sup> July, 2023.

Sir,

I the undersigned have the honour to state that a large number of innumerable unidentified groups of people belonging to the Kuki community with deadly weapons and sophisticated arms including Kuki militants groups stormed to all Meitei inhabited areas of Khuga Tampak, Churachandpur that started on 3<sup>rd</sup> May, 2023 at around 4.30pm. After the said unfortunate incident / mob violence, my family had fledged out of our village and has been taking shelter at relief camp (Ideal Girls College) situated at Akampat, Imphal East, Manipur. My house was not burnt down as it is located next to Singhat's MLA resident. However, on 6<sup>th</sup> July, 2023 morning at around 8:30am to 10:00 am, the said unidentified group vandalized/burnt down my house, and looted all valuable item inside the house. The approximate value of the vandalized / burnt down is Rs. 44,00,000.00

I could not report in time because my wife was hospitalized for almost one month.

It is therefore, prayed that respected Sir may kindly initiate and take necessary legal action(s) against the accused persons and the persons involved in the said inhumane acts, and heinous crime committed by the accused persons and persons involved as per law of the land as early as possible.

I shall be grateful for your kind co-operation and necessary action(s).


