Sir,

Most respectfully I have humble submission before your good office that since the violence broke out in Manipur state from May 3, 2023 in the state of Manipur specially at my birth D. Phailien Meitei Leikai, Churachandpur, Churachandpur district. Large numbers of unidentified groups of people belonging to Kuki-Zo community numbering about 100/200 holding deadly weapons and Kukii militants with sophisticated arms stormed at my house located at D. Phailien Meitei Leikai, Churachandpur, Churachandpur district on 03/05/2023 at around 6.00 pm to 6.30 pm and vandalized and burned down my semi pucca building along with my furniture's and household items and looted away all valuable items kept inside my house by the assailants which caused lost of Rs. 25,00000/ (twentyfive lakhs) approximately.

On the other hand following outbreak of the violence since may 3, 2023 I along with my wife my children abandoned the said house and took shelter at 36 AR Churachandpur along with may Meetei community members for few days and then left 36 AR Camp on 09/05/2023 and stayed at Thangjing Relief Camp, Moirang till 03/06/2023. On 03/06/2023, I along with my family members have been taking shelter at OBC Girls Hostel Urup Higher Secondary School Relief Camp situated Urup under Imphal East district.


In view of the facts I, therefore requested your good office may kindly initiate and take necessary legal action(s) against the persons involved in the said inhuman acts and heinous crime committed by the said accused persons and persons involved as per rule of law as early as possible.
