

Subject:- Request for lodging of FIR case regarding looting and ransacking/burnt.

Sir,

I have the honour to state that on 3/5/2023, a large number of unidentified group of people belonging to Kuki Community with deadly weapons and sophisticated arms including Kuki militant groups stormed to all Meitei inhabited areas of Churachandpur and vandalized the houses of Meitei community.

In that time, I was posted at Guest House located at Gangpimual, Churachandpur as a Civil Engineer for supervision of National Highway (NH)-102B Project.

Due to the said unfortunate incident, I had left the Guest House in the morning of 4/5/2023 and took shelter at BSF Camp situated at Gangpimual, Churachandpur. On the next day i.e. 5/5/2023 at about 3:00 pm, while I was staying at BSF Camp, my Royal Enfield (UNIT OF EICHER LTD) Classic 350, Redditch green in colour bearing registration No. MN01AF/0109, Chassis No. ME3U3S5C1JF739035 and Engine No. U3S5C1JF769177 was burnt down by the unidentified group of people belonging to Kuki Community and looted all my valuable articles which were kept at the Guest House at Gangpimual, Churachandpur.

The approximate value of the burnt down two wheelers vehicle and looted articles are Rs. 246,700/- (Rupees two lakhs forty six thousand and seven hundred).

I could not report to Police in time as I was engaging my youngest sister medical treatment at Apollo Hospital, Guwahati and also to attend my grandmother rites ceremony.

It is, therefore, requested kindly to initiate and taking up necessary legal action(s) against the accused persons and the persons involved in the said inhuman acts and heinous crime committed as per law as early as possible.
