Subject: Request to register a regular FIR against the armed miscreants who perpetrated heinous crime against humanity.

Sir

With reference to the above cited subject, I have the honor to report to you as below:

- 1. That I, T.Seiminthang Haokip age 26 S/o(L) Jangmang Haokip belong to KUKI community, a Schedule Tribe recognized under the Constitution of India. By which I am entitled for protection under the ST/SC (prevention of Atrocities) Act 1989. Where by, I am a permanent resident at N. Zalenphai village, P.S Churachandpur, District Churachandpur.
- 2. That on 3rd August, 2023 at around 2pm, a gun fight ensued in and around my locality, and in the sme firing incident, the Meiteis militias has fired upon numerous rounds of ammunition. Wherein, my residential house located at N. Zalenphai, PO&PS- Churachandpur was hit by 2'inch mortal / 51mm bombs shell, as such my house and properties were damages and destroyed during such ensued gun battle causing me an irreparable loss.
- 3. That, the above said Criminals with their inhuman activities have caused me grave mental and pyschological agony. Notwithstanding the fact that, their unruly activities have made me to suffer a loss of enermous amount of wealth, which is approximately estimated to be around Rs. 28 Lakhs only.
- 4. Due to such attacked upon me and my family, fearing to lose our lives, and being in state of vulnerability had narrowly escaped from these criminals whose intension were to killed us. Henceforth we are taking refuge at ADC Complex Tuibong, Churachandpur.
- 5. That, I am filing this information lately due to my ignorance and harsh living condition. I therefore pray the police to kindly accept my report though filed lately as the same was due to my ignorance and harsh condition not because of my negligence about the matter.
- I, Therefore, request you to register an FIR against the armed miscreants suspected to be Meitei militias and bring them to justice.
