**Subject: Report on crimes of Looting, vandalism of personal Property.**

Sir,

This is to bring to your kind notice that I, Mrs. Phalneikim w/o Jamkhogin, aged about 39 years, belonging to Zou tribe/community would like to state the following facts for your kind consideration and immediate action;

1. That I am a permanent residence of S.Bualjang Village, P.O ; P.S. Churachandpur, Manipur 795128 since the past 3 years.
2. That on the 3<sup>rd</sup> of May, due to the ongoing ethnic clash between the majority Meitei community and the minority Kuki-Zo tribal populace, for fear of being persecuted by the Meitei miscreants, me and my family members were being compelled to desert my home and flee seeking shelter at Tuibuong.
3. That, since the 3<sup>rd</sup> of May, 2023 till the 7<sup>th</sup> of May 2023, we were taking refuge at Tuibuong during which my house was being looted, vandalized by some unknown miscreant.
4. That, the said unknown miscreant activities had caused a huge loss to me and my family, since my stock of rice granary and my secondhand store had been ransacked and looted and also some property inside the said house had been vandalized, the act of which caused a grave mental agony, a total loss which is estimated to be at an amount of Rs. 5,00,000/- (Rupees Five Lakhs) Only.
5. That, without a doubt, there has been delayed in filing of this FIR due to ignorance of the relevant provision of the law and also I was being pre-occupied in maintaining of my family daily needs. Thereby, I humbly request you to register and FIR and look into the matter deliberately.
