

Subject: - Report with regard to the death of *Ms. Nianghoihching*, aged about 33 years, D/o (L) Taitom Kapzalun, a resident of Church Road, Simveng, P.O., P.S. & District- Churachandpur, Manipur.

Respected Sir,



With great grief and concern, I have the honour to make this report (FIR) to you regarding the unfortunate shooting and killing of the above named victim, which I do as under:

1. That, I am the *mother* of the above named victim, *Ms. Nianghoihching*. We belong to the Simte Tribe, a recognised Scheduled Tribe under the Constitution of India, and we are permanent residents of the address mentioned above.
2. That, my daughter, the above named victim, was a nurse by profession and was engaged in the District Hospital Churachandpur privately as she was experienced in conducting *Dialysis*.
3. That, on that fateful day, i.e. 5th May, 2023, my daughter was called for conducting dialysis at the said District Hospital late in the evening. Though the town of Churachandpur was under disturbance, my daughter went for the said dialysis as the patients were very serious and needed the said dialysis. After completing the said dialysis at the District Hospital, my daughter was on her way back home. On the way just before reaching our locality, my daughter had to come through Teddim Road where there was some irate mob who was trying to block the movement of the army personnel. Much to our grave sorrow, there was sudden shooting and unfortunately my daughter was hit by the strayed bullets just below her chest and succumbed to the injury on the spot.

4. That, it may be stated here that I did not report the matter to the police earlier because I was told that there was already a report regarding the incident leading to the unfortunate event of my daughter's death. However, on further inquiry, I have come to know that my daughter's case was not reported accurately. So, I am filing this report in supplement to the already reported/ registered case. Hence, the Police may be kind enough to register my report/ information so that the case of the unfortunate death of my daughter be correctly highlighted and that justice may prevail in the instant case.

I, therefore, request you to kindly register my report, investigate the matter and book the perpetrators as per the prevailing laws of our country. And, for this act of kindness, I shall always remain thankful to you and obliged.
