

Subject: - Complaint Report.

Respected Sir,

I, the undersigned, a victim and refugee taking shelter at the relief camp located at Moirang have honour to report a few words for your kind action that an unlawful mob from Kuki Community having armed and other deadly weapons vandalised and looted our household items and other movable items (enclosed in separate sheet) from our house located at Churachandpur Khumujamba Meitei Leikai on 4th May 2023 at around 8:00 am. They also dismantled and burnt down our house along with a four wheeler vehicle (Maruti Zen) and a two wheeler (TVS NTORQ). The estimated value of the both movable and immovable property destroyed, looted and burnt is to be worth about Rs.80,00,000/- (Eighty Lakhs) only.

The following are the details of the movable items looted during the violence:-


