During the investigation of the above FIR, it has come to light that the other Sir, deceased in the case, Mr. Kamkhogin Kipgen (19) yrs s/o Demmang Kipgen of S. Toljang village was suspected to be killed when mob and AR confrontation happens at Teddim Road, opposite Tuibong Petrol Pump on 04/05/23 at around 8:00 pm. He was taken to Dist. Hospital by KKL Ambulance after the firing incident for treatment but later succumbed to his injuries. Post Mortem of the victim/deceased was conducted on 08/05/20223 where the doctor opined that the victim died of Heart and lung (L) Injury, Homicide in nature. I have recorded the statement of the deceased/victim's family and that of the witnesses and it corroborated with the facts of the case.

Given the above facts and circumstances regarding the difference in the place and time of occurrence between the two deceased/victims in contradiction to the main FIR, Mr. Kamkhogin's case may be separated from the main FIR and investigated under a fresh FIR.
