

That, on 3-05-2023 at about 7:00 p.m. some unknown persons suspected to be Kuki agitators numbering about 1000 started attacking and destroying my house. Seeming the worsening condition, we fled away for our lives.

Now, from my close friend report has received that everything my house and shop has totally damage and looted.

In the above fact and circumstance, I therefore requested that your good self my course of arrest of the miscreants involved in attacking and damaging my house and shop and take up on FIR against them as soon as possible for the interest for justice.


