With due respect I, K. Surjit Kumar, S/o Konjengbam Shyamkanhai Singh, aged 36 years, resident of Tuiboung Zion Veng, Churachandpur- 795128, beg to submit the following few lines for your kind consideration and necessary action.



1. On the 3rd May 2023 at around 6:30pm some unknown miscreants suspected to be Kuki armed group stormed our localities with full arms, they destroyed and burned my residence.
2. The total lost values of my properties and residence is worth around Rs.57,21,000/-
3. Delay in lodging complaint is due to the prevailing law and order situation in Manipur.

It therefore requests you to take necessary action in accordance with the law and against the unknown miscreants suspected to be armed Kuki militants.


