

It is therefore, I am requested you to kindly take up necessary legal action against the said Kuki militant and Kuki civilian. I, couldn't report well in time as I was Diagnosed at Hospital. So, I could not report well in time as well as I have no idea about the law. I, along with my family members presently stay at Relative's House of Keibul Sagram, Bishnupur District Manipur.

So, kindly consider my humble request and take action against the unknown miscreants.
