That, I along with my family members have been settled at Churachandpur District since 2011 living in a rent of one RK Ratankumar @ Swami at Khumujamba Meitei Leikai, PS-CCP, District-Churachandpur, Manipur. But suddenly on 3/05/2023 Kuki Communities male and female including members of KSO, Churachandpur District Student Union and Kuki Militants with Sophisticated and deadly weapons attacked on the Meitei Communities residing at the surroundings of Churachandpur. On the same day at @ 5:30 pm the above rascal miscreants attacked on my rent house and burnt/looted. In the unfortunate and inhuman incident the porperties listed below were burnt/looted by the miscreants.
