

**Subject:** - Report against the killing of Mr. Lalremsang (18 years), S/o Siekmang, a resident of D. Phailian Village, P.O., P.S. & District- Churachandpur, Manipur.

Respected Sir,

With great grief and concern, I have the honour to make this First Information Report to you regarding the unfortunate incident of the shooting and killing of the above-named victim, which I do as under:

1. That, I am the *Father* of the above-named victim Mr. Lalremsang. We belong to the Vaiphei Tribe, a Scheduled Tribe under the Constitution of India, and the victim is a permanent resident of the address mentioned above.
2. That, on the 26<sup>th</sup> of September, 2023 at about 5:40 PM, the above-named victim was a village volunteer who was on duty at a duty post at N. Zalenphai Village (near Torbung Village), P.O., P.S. & District- Churachandpur, Manipur. And, at the time, guarding the area from the attack of the majority Meetei/Meitei community, he was unfortunately shot at on his left chest by a bullet. After which he was rushed to the Samaritan, Churachandpur. But unfortunately, he succumbed to his injuries and died at about 9:30 AM on the 27<sup>th</sup> September, 2023. Hence, this instant report.

3. That, it may be reported here that the attack on the instant victim was carried out because he belonged to the Kuki-Zo tribal community. In fact, the majority Meitei community were heard shouting "Kuki hatlo", "Hao hatlo", etc. meaning- "Kill the Kukis", "Kill the tribals", etc while they were carrying out their criminal activities.

That, I am filing this information lately because of the unexpected loss of a member of our family, which taunt and traumatized me and my family, therefore, I request you to kindly register my report, investigate the matter; arrest the culprits involved in the gruesome act and book them under relevant sections of the law of our country. And, for this act of kindness, I shall always remain thankful to you and obliged. Thus, I am filing this report lately, today.
