Sir,

As endorsed to me I have conducted discreet enquiry into the matter and go through the video provided by the complainant in one pen drive and found that the complaint filed by the complainant namely Mr. V. Chinkhenpau (46) s/o. (L) V. Khamzathang was found to be true (Copy enclosed).

The video which streamline the speech delivered by one Shri. Rameshwor, MLA Keirao Kendra Assembly Constituency was broadcasted on ISTV news and went viral on Social Media. Keirao Legislative assembly Constituency is the 6th AC among the 60 Legislative Assemble Constituency of Manipur. On 25/07/2023, the said Hon'ble MLA had delivered the speech at the passing out parade of Meitei Village Volunteer at Sinam Village under Keirao Assembly constituency. Seized the Pen drive u/s. 65 B IEA Act on production by the complainant.

The pen drive comprises of two short video clips. The first video is about 2 minutes and 57 second in length which streamline the ISTV News and include the speech of Hon'ble MLA Rameshwor. The second video is about 2 minutes and 5 seconds in length which streamline the speech of Shri. Lourembam Rameshwor Meitei s/o. Lourembam Iboton Singh of Keirao Hon'ble BJP MLA, 6th Keirao Assembly Constituency.

In his 2 minute and 05 second speech, the Hon'ble MLA had categorically stated that "The Kuki's are not protesting against the Government, if they are protesting against the Government, they can burnt many government offices, instead of burning Govt. offices since May 3/5/2023 they are burning Meitei houses at Torbung village. They rape Meitei young girls, their plan is to chased out the Meiteis and to occupied their lands. It's better not to live with them, cleaning all the Kuki's from our soils is the best option now. Since 28/04/2023 they have invited international media in churachandpur. This shows the pre-planned war made by the Kuki's. On 29/04/2023 they started burning Meitei Pakhangba Laishang. So far the Kuki's had burned 300 to 400 places of worship of the Meitei. The Kuki's are war mongering community, they had a war with Karbi, Dimasa, in Tripura, in Myanmar and in Bangladesh they don't have a place to live. They fight with every communities. Kuki's are the worst creatures made by God and had sent to this world to create troubles. So, why should we live together with them any further? After exploiting the environment by Poppy cultivation, the money they earned is used for exploiting the Meitei youth populace by giving drugs. The Kuki's killed more than 1700 innocent life of the Meitei in fake encounter. Kuki's are demanding separate country from India so they are killing the innocent Meitei. But our demand is not to be separated from India, we are just protecting our land. Give us some more time, we will face them. Total cleansing of Kuki's from our land wouldn't take even a week".

From the above speech delivered by Shri. Lourembam Rameshwor Meitei s/o. Lourembam Iboton Singh of Keirao Hon'ble BJP MLA, 6th Keirao Assembly Constituency we can come into conclusion of the following points which attracts several sections of laws.

In his speech the Hon'ble MLA had categorically stated that "It's better not to live with them (Kuki's), cleaning all the Kuki's from our soils is the best option now. So, why should we live together with them any further? Give us some more time, we will face them. Total cleansing of Kuki's from our land wouldn't take even a week".

These narrations made by Hon'ble MLA Shri. Lourembam Rameshwor Meitei is direct contravention with section 505 IPC which stated that:-

Statements conducing to public mischief: (1) Whoever makes, publishes or circulates any statement or report:-

(a) with intent to cause, or which is likely to cause, fear or alarm to the public, or to any section of the public whereby any person may be induced to commit an offence against the state or against the public tranquility or

(b) with intent to incite, or which is likely to incite, any class or community of person to any offence against any class or community,

(2) Statements creating or promoting enmity, hatred or ill will between classes:- whoever makes, publishes or circulates any statement or report containing rumor or alarming news with intent to create or promote, or which is likely to promote, on grounds of race, place of birth, residence, language, caste or community or any other ground whatsoever, felling of enmity, hatred or ill will between different racial, language or regional groups or castes or communities.

As such, the narrations made by Hon'ble MLA Shri. Lourembam Rameshwor Meitei attracts Section 505 IPC.

In his speech Hon'ble MLA Shri. Lourembam Rameshwor Meitei had again categorically stated that "They (Kuki's) rape Meitei young girls. Since 28/04/2023 they have invited international media in Churachandpur. The Kuki's are war mongering communities, they had a war with Karbi, Dimas, Tripura, in Myanmar and in Bangladesh they had no place to live. They fight with every communities. Kuki's are the worst creatures made by God and had sent to this world to create troubles. After exploiting the environment by Poppy cultivation, the money they earned is used for exploiting the Meitei youth populace by giving drugs. Kuki's are demanding separate country from India".

These narrations made by Hon'ble MLA Shri. Lourembam Rameshwor Meitei is direct contravention with section 499 IPC which stated that:-

Defamation:- Whoever, by words either spoken or intended to be read, or by signs or by visible representations, makes or publishes any imputation concerning any person intending to harm, or knowing or having reasons to believe that such imputations will



harm the reputation of such person, is said, except in the case hereinafter expected, to defame that person.

- 1) It may amount to defamation to make an imputation concerning a company or an association or collection of persons as such
- 2) An imputation in the form of an alternative or expressed ironically, may amount to defamation.

3) No imputation is said to harm a person's reputation, unless that imputation directly or indirectly, in the estimation of others, lowers the moral or intellectual character of that person, or lowers the credit of that person, or cause it to believe the body of that person is in loathsome state, or in a state generally considered a disgraceful.

As such, the narration make by Hon'ble MLA Shri. Lourembam Rameshwor Meetei attracts section 500 IPC.

In his speech Hon'ble MLA Shri. Lourembam Rameshwor Meetei The Kuki's had again categorically stated that "They (Kuki's) are not protesting against the Government, if they are protesting against the Government, they can burnt many government offices, instead of burning Govt. offices since May 3/5/2023 they are burning Meitei houses at Torbung village. This shows the pre-planned war made by the Kuki's. On 29/04/2023 On 29/04/2023 they started burning Meitei Pakhangba Laishang. So far, the kuki's had burned 300 to 400 places of worship of the Meitei. The Kuki's killed more than 1700 innocent life of the Meitei by fake encounter. These narrations make by Hon'ble MLA Shri. Lourembam Rameshwor Meetei is direct contravention with Section 153 A IPC which stated that:-

Promoting enmity between different groups on grounds of race, place of birth, residence, language etc, and doing acts prejudicial to maintenance of harmony:- (1) Whoever

- (a) *By words, either spoken or written, or by sign or by visible representations or otherwise, promotes or attempts to promote on grounds of race, place of birth, residence, language, caste or community or any other ground whatsoever, disharmony or feeling of enmity, hatred or ill-will between different racial, language or regional groups or communities, or*
- (b) *Commits any acts which is prejudicial to the maintenance of harmony between different racial, language or regional groups or communities, and which disturbs or is likely to disturb the public tranquility, or*
- (c) *Organize any exercise, movement, drill or other similar activity intending that the participants in such activity shall use or be trained to use criminal force or violence or knowing it to be likely that the participants in such activity will use or be trained to use criminal force or violence or knowing it to be likely that the participants in such activity will use or be trained to use criminal force or violence, against any racial, language or regional group or community and such activity for any reason whatsoever causes or is likely to cause fear or alarm or a feeling of insecurity amongst members of such racial, language or regional group or community.*

As such, the narrations make by MLA Shri. Lourembam Rameshwor Meetei attracts Section 153 A IPC.

From the above facts and circumstances of my enquiry, cognizable offence could be established from the statement of MLA Shri. Lourembam Rameshwor Meetei. So, I therefore, prayed to you to kindly register a regular case against MLA Shri. Lourembam Rameshwor Meetei u/s. 153A/500/505 IPC for his derogatory remarks against the Kuki community.
