I, the undersigned would like to laydown the following facts before you in favour to take Sir, necessary actions, thereof.

That, My resident at Tolbung Village, PO Tolbung, Kangvai Block, Churanchanpur District, Manipur On the 3rd May 2023 at around 2 pm, unknown miscreants belonging to Meitei community numbering more than 1000 people suspected to be members of Arambai Tengol, Meetei Leepun and other have attacked our village by holding deadly weapons including automatic Rifles and Bomb. The miscreants have ransacked, looted my House and all properties.

The details of properties lost are as follows:

Resident house, Gas stove, cylinder (3), Kitchen items, Bed (3), Almirah (2), Smart TV, Solar plate, Washing machine, Battery, Sofa set, Kitchen Almirah, Sintex (2, 500L), Dining table, Dinner set, Dressing table, 4 San, Necklaces, earrings (2), bicycle, Dog (2), Hen (5) and other valuable materials like documents were also burnt.

The total worth of properties lost is estimated to be about Rs. 8,00,000 (Eight lakhs)

That, I could not report the incident to my concerned police station, as we were on the run and no longer has access to Imphal.

Therefore, I request you to take necessary actions at your end. I shall remain ever
