

Sir,

I the undersigned beg to report for your kind and necessary action..

That, on 3rd May, 2023 at around 8:00 pm, while I along with my wife was at a rented house of Meitei Youth Organization located at Khumujamba Meitei Leikai P.O. Churachandpur, P.S. Churachandpur, District Churachandpur, Manipur, unknown armed miscreants including Hmar, Zou, Simte, Paite & Vaiphei attacked the house, vandalized/looted and burnt. In the incident my valuable properties worth about Rs. 3,78,000/- (Rupees three lakhs seventy eight thousand) was burnt/looted by the miscreants mention above.

That, the unknown miscreants are suspected to be the Kuki tribe as they conversed among themselves in the Kuki dialects while firing and looting the house. I could not report to the Police Station timely due to displace and unrest the present law and order situation.

It is therefore requested to take up necessary legal action against the Kuki miscreants and punish them as per law.
