

Sir,

With due respect, I have the honour to state that I along with my family run a farm house of unsurveyed hill land measuring an area of about 70(Seventy) Acres, covered by Regn. Of L/Deed No. 1/2005, dated 08/07/2005. I have run the farm house for the last 18 years with my ancestral parents. On the farm we planted Ginger, Banana Trees, Jatropha Curcas plant, Local vegetables etc. with full fencing of the whole area by iron Barb Wire.

That, in between 3rd May to 6th May 2023 some unknown miscreants belonging to Kuki Community burnt down our Katcha house which is located at the Hillside near M Simol Village, Churachandpur with criminal intention to cause damage of property and life with deadly weapons including automatic rifles, knives etc. All the properties of the farm house were destroyed and burn into ashes and looted by the unknown miscreants

The approximate total loss of properties would be Rs. 1(One) Crore.

It is therefore kindly requested to take necessary legal action on those culprits were involved in the incident. I hereby lodged my complaint at Lamphel Police Station as I had fled from my residence for the safety reasons. The cause of delaying my report is due to on searching for safety place for residing.
