

Subject:- Complaint report.

Sir,

With due respect, I have the honour to state that I am the resident of Yaiphakol, Thingkangphai, Churachandpur District, PO/PS:- Churachandpur-795128, Manipur.

That on 3<sup>rd</sup> May 2023 at around 4.30 pm some unknown miscreants belonging to Kuki Community burnt down my house with criminal intention to cause damage of property and life with deadly weapons including automatic rifles, knives etc. As a results many houses and properties worth crores were destroyed and burnt to ashes. Among which my house under New Patta No.58/319 and C.S Dag. No. 388 of 58- Thingkhangphai Lourup, Churachandpur of Ingkhol class permanent resident was also destroyed by the mob. Many valuable properties were burnt and leftover were looted.

Lists of properties (both immovable and movable looted, burnt and destroyed are given below)

1. Semi Pacca House build of Homestead Land worth Rs. 300000/- (Three lacs)
2. 15 (Fifteen) nos. of Pigs worth about Rs. 16,000 X 15 = Rs 2,40,000/-
3. 50 (Fifty) ton of rice worth about Rs. 50,000/- (Fifty Thousand)
4. Nos. of hens and ducks amounting to 80,000/ ( Eighty Thousand)
5. Nos. of gold ornaments amounting to Rs. 3,00,000/- ( Three Lakhs )
6. Grocery items amounting of Rs. 3,50,000/(Three Lakh Fifty Thousand)
7. Others household articles

The approximate total loss of properties would be Rs. 1 Crores.

It is therefore kindly requested to take necessary legal action on those culprits were involved in the incident. I hereby lodged my complaint at Lamphel Police Station as I had fled from my residence for the safety reasons. The cause of delaying my report is due to on searching for safety place for residing.


