

Subject:-Complaint report.

Sir,

With due respect, I have the honour to state that I am the resident of Thingkangphai Village, Yaiphakol Churachandpur District, PO/PS:- Churachandpur-795128, Manipur.

That on 3rd May 2023 at around 6.30 pm some unknown miscreants belonging to Kuki Community burnt down my house with criminal intention to cause damage of property and life with deadly weapons including automatic rifles, knives etc. As a result, many houses and properties worth crores were destroyed and burnt to ashes. Among which my house under New Patta No.58/319 and C.S Dag. No. 388 of 58- Thingkangphai Yaiphakol, Churachandpur of Ingkhol class permanent resident was also destroyed by the mob. Many properties were burnt and leftover were looted.

Lists of properties (both immovable and movable looted, burnt and destroyed are given below)

1. Residential wooden house
2. 35 (Thirty-Five) nos. of Cow worth about Rs. 70,000 x 35 = 2,450,000/- (Twenty-four lakhs fifty thousand)
3. 15 (Fifteen) nos. of Pigs worth about Rs. 20,000 X 15 = 3,00,000/- (Three lakhs)
4. One Hundred ton of rice worth about Rs. 1,50,000/-
5. 500 nos. of chicken and 200 nos. Duck worth of about 4,90,000/- (Four lakh ninety thousand)
6. 20 (Twenty) Nos of Gold worth about Rs. 3, 50,000/- i.e. one necklace, Six nos. Ring and Eight nos. Ear Ring.
7. House Hold furniture worth about Rs. 3 Lakhs (Rupees, Three Lakh)
8. Others household articles.

The approximate total loss of properties would be Rs. 3 Crores.

It is therefore kindly requested to take necessary legal action on those culprits were involved in the incident. I hereby lodged my complaint at Lamphel Police Station as I had fled from my residence for the safety reasons. The cause of delaying my report is due to on searching for safety place for residing.




