

Sir,

With due respect, I have the honour to state that I am the resident of Yaiphahol/Thingkhangphal, Churachandpur District, PO/PS:- Churachandpur-795128, Manipur.

That on 3rd May 2023 at around 6.30 pm some unknown miscreants belonging to Kuki Community burnt down my house with criminal intention to cause damage of property and life with deadly weapons including automatic rifles, knives etc. As a result many houses and properties worth about 67 lacs were destroyed and burnt to ashes. Among which my house under New Patta No. 58/319 and CS Dag. No. 388 of 58-Thingkhangphal Yaiphahol, Churachandpur of Ingkhol class permanent resident was also destroyed by the mob. Many properties were burnt and leftover were looted.

Lists of properties (both immovable and movable looted, burnt and destroyed are given below)

1. House build in Three plot of Homestead Land worth Rs. 500000/- Five lacs
2. Saw mill including Timbers worth about (Rs 80,000 + Rs 20,00000)
3. 4 (four) Cows (HisanForsan worth about Rs. 400000/-Four Lakhs)
4. 3 three young Cows which do not bearing calves worth about Rs. 165000/- 1lac and sixty-five thousand
5. Grocery Shop worth about Rs 200000/- 2lacs
6. 2 Sows (mother pig) along with 15 piglets worth about Rs 85 thousand.
7. 10 Ducks worth's about Rs 10,000/- (ten thousand)
8. One Buffalo with one female Buffalo along with Calve buffalo worth about Rs 140000/-1lac forty thousand
9. 30 Paddy bags worth about Rs 30,000/-
10. 3 Beds and two almaris worth about 60,000/- sixty thousand
11. Gold Jewelry three and half Tolas worth about 252000/- two lacs fifty-two thousand
12. Cash Rs 130,000/- one lakh Thirty thousand
13. TV Set worth 1,50,000/-
14. 2 Gas Cylinder (one filled) 1(1000Lt.), one syntax and 1(one) 500lt.syntax worth Rs 17,000/- seventeen thousand
15. One washing machine Samsung worth Rs 14,000/-
16. One activa 125 BS VI without registration No. (New)
17. Two Saktiman Bearing Regd. Nos 1) MN01-3841 2) MN04-2195 worth total Rs 15,00000/- (fifteen lacs)
18. Firewood seven loads worth about Rs315000/- (three lacs fifteen thousand)
19. Van bearing regd. no. (MN1A 6316) with one cycle with gear total worth Rs 125000/-
20. Tractor Sonalika 4x4, thrasher machine and Rotavator with one Kamko Machine worth Rs 500000/- (five lakh)
21. Laptop with Printer machine 1,20,000/-
22. Bench Saw mill, Circular Saw and Hand Creng worth Rs 85,000/- eighty-five thousand

The approximate total loss of properties would be Rs. 67,10,500.

It is therefore kindly requested to take necessary legal action on those culprits were involved in the incident. I hereby lodged my complaint at Lamphel Police Station as I had fled from my residence for the safety reasons. The cause of delaying my report is due to on searching for safety place for residing.


