

Subject : Report.

Sir,

I have the honour to report that on 03/05/2023 at around 6:30 pm following by a mass rally of Tribal Solidarity March, a large number of armed Kuki miscreants suspected to be Kuki militants came to our locality at Thengra Leirak, Red Cross Road, Churachandpur in an organised form holding deadly weapons like Gun, Swords, Dao, Stick etc and start destroying, looting, burning the houses belonging to our Meitei community. In that violence the said armed kuki miscreants looted, destroyed all my properties and set fire my own One storey Pucca Buiding with other apartments along with Latrine and Bathroom which was constructed separately. As a result my house/Pucca building with other apartments along with Latrine and Bathroom and all house hold items belongings of movable properties and valuable documents which were left therein were razed to the ground. In that incident the approximate value of my lost properties is around Rs. 82,70,000/-.

The list of the properties which was looted and burnt down are shown as below:-

1. One storey pucca building-	Rs. 60,00,000 /-
2. Latrine and Bathroom	Rs. 3,50,000/-
3. Furniture items -	Rs. 2,50,000 /-
4. Electronic items -	Rs. 3,20,000 /-
5. Other Household items -	Rs. 2,80,000 /-
6. Cloths (Men, women, kids) -	Rs. 1,70,000 /-
7. Jewellery-	Rs. 4,30,000 /-
8. In cash	Rs. 4,70,000 /-
Total amount=	Rs. 82,70,000/-

In the light of the above facts and circumstances, it is Therefore requested to kindly take-up FIR against them and may cause the arrest of the unknown kuki armed miscreants as soon as possible. The report could not be submitted timely as I was confined on duty as a teacher and out of station for medical treatment of my wife at Guwahati and also due to the prevailing law and order situation in the state.
