Subject :- Report on Looting, Vandalism and burning down of house, household items/assets/Documents and Discrimination of Schedule Tribe.

Sir,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I, **Jamlenmang Kilong S/o Haokholun Kuki**, Elder Brother of **Personal No. 4385285K, Rank-Sepoy. Shri. Seiboi Kuki of 5th Assam Regiment**, aged about 32 years Belonging to the Any-Kuki Tribe / Community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a permanent Resident of **Saiton Khonou Village Churachandpur District Manipur. P.O&P.S., Churachandpur**.
2. That at about **11:40 pm** on the **3rd May 2023**, a huge contingent of armed radical meitei/Meitei suspected to be members of the Arambai Tengol and Meitei Leepun along with a mob numbering about 200 attacked our Village with sophisticated weapons. so in order to save our lives we left behind our house and also the house of my brother **Seiboi Kuki** which was adjacent to our house (in the Same Pataland) with all our belongings, and in the process they have looted then burnt down the house of my brother Seiboi Kuki, including all his household items and also his Domesticated animals, Granaries etc.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony to my brother (Seiboi Kuki) and incurred huge loss which may be estimated to be **Rs. 20,00,000/- (Rupees Twenty Lakhs) only**.
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health . And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And for which act of kindness, I shall always remain thankful to you and obliged.
