Sir,

I have the honour to state that on 3/05/2023 at about 7.30 p.m. some unknown tribal persons holding deadly weapons like gun, stick, etc. came in a war footing manner including sounds of gun fire in my locality, seeing the apprehending situation somehow along with my family members escaped from the place for safety, however the unknown persons set fire/damaged my dwelling house constructed at Khuga, Jampok, Meitei, Leikai, (ok Bazar) and all my belongings and properties turned into ash. As such I and my family suffer huge loss and untold sufferings beings homeless with nothing to survive. So, your kindness be please to take necessary action against the culprits as well as our rehabilitation measures. I could not report earlier in the tense situation and now reported when there is little normalcy in the locality but not stable.
