With due respect, I, the undersigned namely *Ningthoujam Bhanupati Leima*
aged about years, resident of *Tuibang Zion Veng C.C. Pura*
beg to submit the following few lines for your kind consideration and necessary action.

That on *4 May*, at about *11:30 pm*, some unknown persons numbering
about *400* belonging to Kuki community started attacking the undersigned along with family
members. Therefore, the Kuki people started destroying and burning the house of the
undersigned resulting in all the properties of the undersigned were razed to the ground and all
the belongings and jewellerys were also burned/destroyed/ stolen before burning/damage.

In the said the properties damaged/destroyed by the miscreants is about Rs. *12,00,000*
(Rs. *Twelve Lakh*).

I could not report well in time due to leakage idea of FIR to nearest police station intently.

I am taking shelter at *Maimang Khunou Mamang Sabal Maidoh*

A separate sheet showing the particulars of all the losses incurred is attached along with the
present application.

In the above facts and circumstances, it is therefore respectfully requested that your goodself
may cause the arrest of the miscreants who belong to the Kuki community involved in the
burning/dismantling/damaging my properties and take up an FIR against them as soon as
possible for the interest of justice.
