

That on 4th of May 2023 at about 8:00 am some unknown persons numbering about 150 belonging to Kuki-Zo community with gun looting and vandalize my shop at Churachandpur New Bazar resulting in all the properties of the undersigned looting and vandal. The items loss worth around Rs 9,20,000 (Nine lakh twenty thousand) is also enclosed for your reference.


