


Subject:-Request for lodging of FIR case regarding arson/damage & looting of household properties.

Sir,

I, the undersigned have the honour to state the following few lines for your kind consideration and further necessary action.

That, a large number of unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including Kuki militants groups stormed to all Meitei inhabited areas of Churachandpur Town on 3rd day May, 2023 at around 4:30 pm. They started destroying, looting and burning down the houses and house hold properties of Meitei community. Due to fear and panic, I along with my family left my rented house located inside the premises of Partnership Mission Society, Hmarveng Meitei Leikai, Churachandpur and now taking shelter at the residence of our relative located at Bamdiar Makha Leikai, Imphal West. On 18/06/2023 at 5:00 pm, it is learnt as told by the villagers of Hmarveng that on the same day at around 1:00 pm my rented house was damaged, set on fire and looted the remaining valuable properties by some unknown armed miscreants suspected to be Kuki militants. The approximate value of the loss properties is Rs. 13,55,000/-(rupees thirteen lakhs and fifty five thousands) (enclosed list of loss properties as Annexure A). I could not report well in time due to lack of legal knowledge and displacement.
