

**Subject:** - Complaint/ Report on crimes of **vandalism, use of Mortars** and **discrimination of Scheduled Tribes.**

Dear Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

1. That, I am a Scheduled Tribe belonging to the Vaiphei Tribe, which is a recognized Tribe under the Constitution of India. And, I am a permanent resident of Kangvai Village, P.O., P.S. & District- Churachandpur, Manipur.
2. That, on the 4<sup>th</sup> of May, 2023, at about 2:30 PM, a huge contingent of armed radical Meitei/ Meeteis suspected to be members of the Arambai Tenggol and Meitei Leepun headed by the Manipur State forces like the Manipur Police Commando attacked our village and, in the process, they have vandalized my house, they even tried to torch the house but our village members stopped them and the attack doesn't end there. I would also like to include here, that on the 28<sup>th</sup> of August, 2023 at around 7:30 AM, the said Meitei/ Meeteis criminals along with the Valley Based Insurgent Groups (VBIs) attack our village using Mortar Bombs which resulted in blowing up the roof of my house.
3. That, it may be reported here that the miscreants were shouting slogans like- "KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because everyone, including top officials of the Manipur Government are patronizing them and that that no harm could be done to them.
4. Therefore, the total loss suffered is estimated to be about **Rs. 1,20,000/- (Rupees One Lakh Twenty Thousand)** only.
