With reference to the above cited subject I have the honour to report to you as follows:

- 1. That I, Personal No. 4380991F, Rank-Sepoy. Lamlallun Gangte of 7th Assam Regiment Currently posted at Uttarakhand (Auli). aged about 29 years S/o Henkhokam Gangte Belonging to the Gangte Tribe / Community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that I am a permanent Resident of K Thenjang Village Churachandpur, Manipur. P.O&P.S., Churachandpur.
- 2. That at about 7:30 pm on the 3rd May 2023, a huge contingent of armed radical meeitei/Meitei suspected to be members of the Arambai Tengol and Meetei Leepun along with a mob numbering about 1000 attacked Torbung Khovaiphei Village. And in the process some unknown miscreant burnt down my house at Torbung Khovaiphei Village which was given out by me as a rented house.
- That, it may be reported here that the above said criminal activities have caused grave mental
 agony and incurred huge loss which may be estimated to be Rs. 8,00,000/- (Rupees Eight
 Lakhs) only.
- That, I am filing this information lately because I was at my posting place at Jammu (Domana). And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
