Imphal West Dist., Manipur

Sir,

With due respect, I, the undersigned namely **Ningthoujam Ibomcha Singh**,  
s/o, (L) **Ningthoujam Ibobi Singh** aged 45 about years, resident of **Khumujamba Meitei Leikai**,  
Churachandpur beg to submit the following few lines for your kind consideration and necessary  
action.

I, a resident of Khumujamba Meitei Leikai, owned and run a business establishment, as  
herbicides, pesticides and seeds store, bearing license no. ADCC/C1(32)/384/(8-B)/2018-10, Fssai-  
License No. 11617004000049 near Nute Market, New Bazar, Churachandpur.

That my shop was safe for a couple of months but suddenly in continuation of the clashes  
that began on the 3<sup>rd</sup> of May 2023, reports came in on 13<sup>th</sup> September, 2023, at around 11 a.m, that  
some unknown miscreants belonging to the Kuki community started attacking the properties,  
business establishments of the undersigned. Therefore, the Kuki people started looting the shop  
thereby resulting in huge loss of all the properties of the undersigned.

In the above facts and circumstances, it is therefore respectfully requested that your good  
self may cause the arrest of the miscreants who belong to the Kuki community involved in the  
looting of my properties and take up an FIR against them as soon as possible in the interest of justice.
