I, the undersigned, have the honour to state that on 04/05/2023, I along with my driver have left our work place i.e. Benia Zou Village under CCP-PS, Churachandpur District, Manipur due to the Communal riot between Meitei and Kuki to save our life. On the same day at @ 8:30 am at Mata village, CCP-PS, Churachandpur district, Manipur my SX4 car Silky silver in colour bearing Reg. No. MN06LA7753, Chassis No. MA3EFJCIS00176775, Engine No. M16AN2036954 was looted by 15/20 unknown persons suspected to be Kuki Militants. The approximate Value of the Looted Vehicles is @ Rs. 3,50,000/- (Rupees three Lakhs and fifty thousand) only. Delay of filing of this report is due to the current unrest law & order situation.

So, I therefore request you to kindly take up legal necessary actions against the above mentioned unknown accused.

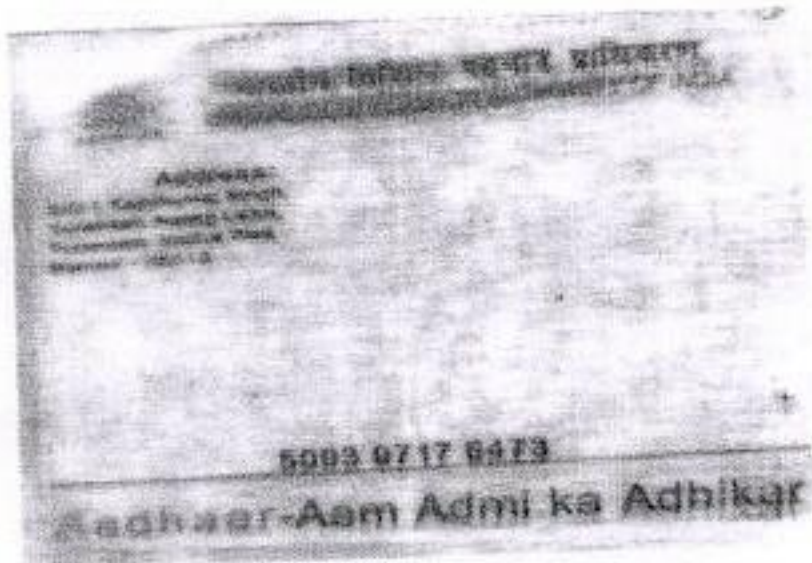
