Sir.

With reference to the above cited subject I have the honour to report to you as follows:

- That I Thianneiniang aged about 49 years W/o John Belonging to the Vaiphei Tribe / Community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that I am a Permanent Resident of Kangvai Village, P.O & P.S., Churachandpur.
- That at about 2:30 pm on the 4th May 2023, a huge contingent of armed radical Meeitei/Meitei suspected to be members of the Arambai Tengol and Meetei Leepun and a mob attacked our Locality at the above mentioned address. So, in order to save our lives, we left behind our house with all our belongings including our domesticated animals in the process they have looted Vandalised then then burnt down our house including all our belongings along with our domesticated animals (12 Cows and 3 Pigs).
- That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs. 40,00,000 (Rupees Fourty Lakhs) only
- 4. Fortunately, I managed to escaped from the criminals who even tried to kill us, and now currently taking refuge at Tualnuam Village, Churachandpur.
- That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at the above mentioned address. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
