I have the honour to report that on 3/5/2023 at around 7 pm, a large number of innumerable unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including kuki militant groups stormed to all Meitei inhabited areas of Churachandpur town. The said unidentified groups burnt down my rented house located at Churachandpur Meitei Leikai Thengra Leirak and also looted all valuable items. In that unfortunate incident, I have lost a total amount of Rs. 13,00,000 (approx.).

It is therefore, requested to take necessary legal action against the accused persons and persons involved in the said inhuman acts and heinous crime committed by the accused persons and persons involved as per law.




