I have the honour to report that large number of innumerable unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including kuki militant groups stormed to all Meitei inhabited areas of Churachandpur town on 4/5/2023 at around 4:30 pm.

The said unidentified groups vandalized and extorted my Tata Backhoe loaders machin model No. 315V machine No. 8646 Engine No. 497TC and Tata Tipper B/Regn. NO. MN07C-4271 from Haolai Khupi Village.

The approximate value of the extorted articles is Rs. 35,00,000/- (rupees thirty five lakhs) only.

It is therefore, requested to take necessary legal action against the accused persons and persons involved in the said inhuman acts and heinous crime committed by the accused persons and persons involved as per law.


