

Sir,

With, due respect I, would like to report that a residence house of **Army No.437401811 Naik. Goulalman serving in 9<sup>th</sup> Assam Regiment** at Torbung Village, P.O.&P.S. Churachandpur, district Churachandpur was Vandalized, looted and damaged beyond repairable by Meitei miscreant on the night of 3<sup>rd</sup> May 2023 at around 9:00pm while attacking Torbung Village at the start of ethnic clash in Manipur.

That, this wanton rampage act of miscreant has cause property loss and damage to the mention personnel which may amount to INR 20,00,000/- (Rupees Twenty Lakhs only).

That, I am filing this report with such delayed after learning that no report of this incident was made to this police station as he was away in his place of posting at Lucknow, Uttar Pradesh.

I, therefore, request your kind office to take necessary action at the earliest, for which kind act I will remain obliged to you.


