


Sir,

1. Yanglem Jibon Singh, resident of Toubul Awang Mayai Leikai, Ward no.2, have been working as an assistant teacher in Manipur Boarding School, Gelmol near Tronglaobi for the last five years. I stayed in one of the quarter inside the School campus with my family. The staff and faculty members of the school is mostly the Kuki people. The recent incident that was taken place between Meitei community and Kuki community because of the conflict that happens in these two communities gives my family a great impact. The incident took place from 3<sup>rd</sup> May 2023. I and my family left the school on 4<sup>th</sup> May 2023 in the early morning being locked the quarter. After three days I went to the school to check the quarter and its surrounding. In this atmosphere I cannot enter the school alone because some Kuki people were surrounding that area. So I took the help of some weaponed people and entered the school campus. When I reached there the doors and windows of the quarter was found broken and most of the valuable things including gold and money from inside my iron almirah were no more. I took out only some of the small things from the quarter and came out. Most of the household articles cannot carry out from the school because of the limited time. I heard afterward that all the articles were taken away by some suspected kuki Militant. I request you all to kindly make a possible arrangement to able to get back the lost things under your kind best effort in the interest of my victim family and grateful forever.

I am listing the articles lost from my quarter here below:

1. Two three person seated sofa and two one person seated sofa. - Rs. 60,000/-
2. One book box and one kitchen utensil box and one gas box. - Rs. 50,000/-
3. One TV stand with box attached and two tables and a pair of desk and bench. - Rs. 50,000/-
4. One syntax (500 litres) and one syntax (300 litres). - Rs. 4,500/-
5. One big silver tub. - Rs. 1500/-
6. One refrigerator and one semi-flat TV. - Rs. 25,000/-
7. Two shoe boxes and two gas cylinders with stove. - Rs. 30,000/-
8. One immersion heater. - Rs. 500/-
9. One wooden double bed. - Rs. 30,000/-
10. One wooden cloth box. - Rs. 20,000/-
11. Two spades and other garden tools. - Rs. 2000/-
12. One Tata sky TV disc with set top box. - Rs. 2000/-
13. Kitchen utensils. - Rs. 20,000/-
14. Clothes - Rs. 60,000/-
15. Gold - Rs. 68,000/-
16. One Stand Fan - Rs. 2600/-
17. Water Pipe (200 m) - Rs. 2000/-
- Total Amount - Rs. 426,100/-





