Sir,



I am writing to report that I am a resident of Khumujamba Meitei Leikai, Zenhang Lamka, Churachandpur District and running a Garment shop, rented from MYO(Meitei Youth Organisation) near my residence specially deals in ladies jwellery, ornaments, garments such as Rani Phee, Phige etc and other garments used at the time of traditional Manipuri occasions. I am further to report that on 3rd May 2023 at around 7.30 pm some armed / unarmed kuki militants numbering around 200-300 stormed at the said area and started vandalised house hold properties of Meitei/Meetei communities. In that, the same miscreants assaulted my family members, ransacked/ destroyed all the items inside the Shop and later burnt the said building into ashes.

The approximate lost amount of my properties is around 25(twenty-five) lakhs in the present market price.

I could not report well in time due to present law and order situation and my family members were stranded & lost. Later we arrived and took shelter at a rented house in Bishnupur Ward No.9.

It may be added that I was out of state for medical treatment of my daughter in-law's preganancy complication and my father & mother in-laws health problem at Delhi. And a few days ago I retuned back to Bishnupur Ward No.9.

It is therefore, requested kindly to take up necessary action.
